



Who are our volunteers?

Approximately 45 dogs of all breeds, shapes and sizes have passed our rigorous therapy dog certification test and promote healing, health, and hope. Over 100 people working in our programs; developing new and innovative applications for animal-assisted therapy; staffing outreach events and our program evaluation efforts; educating the community about animal-assisted therapy and humane issues; publishing our newsletter; and planning fundraising events.

Dear Sir or Madam:
